- 1. The Proctor of the University is an office by Act No 41, 2001 is directly responsible to the Vice-Chancellor. He will be assisted by Assistant Proctors who shall remain responsible to the Proctor.
- 2. Following shall be the main duties of the Proctor:
- i) He shall be responsible for over all discipline and conduct of students within the University campus outside the Halls.
- ii) He shall perform such other duties regarding discipline of students as may be deemed necessary by the Vice-Chancellor from time to time.
- 3. The Proctor if he finds necessary, may recommend to the Vice-Chancellor for appointment of a prefect or prefects from amongst the senior students to help him for maintaining discipline and order in the University.
- 4. i) The Proctor shall take such steps as he thinks necessary for the purpose of ensuring disciplined behavior and good conduct on the part of every student at all the hours round within the University campus outside the Halls.
 - ii) The students of the University will be provided with identity cards, which they must produce on demand by the Proctor or the Assistant Proctors.
- 5. i) The Vice-Chancellor may delegate such of his disciplinary powers as he may deem fit to the Proctor. The Vice-Chancellor shall issue standing orders as regards the extent of the power he delegates to the proctor.
 - ii) The proctor shall have power to impose on a student a fine upto Taka 1000/-(One thousand) at a time for a breach of discipline or misconduct in the University outside the Halls. Any fine imposed by the proctor on a student shall be reported to the Provost of the Hall to which the student belongs. If, however, the Proctor is of the opinion that the case requires expulsion of the student from the University he shall refer the case to the Vice-Chancellor for such action as he may deem fit.
 - iii) The Assistant proctors shall have powers to impose on a student a fine not exceeding Taka 500/- (Taka five hundred) at a time for breach of discipline or misconduct and report their action to the Proctor and the Provost of the Hall concerned who will report such to the Vice-Chancellor.
 - iv) The fine imposed by the Proctor / Assistant Proctors, as the case may be, shall be duly collected. The case shall be reported to the Vice-Chancellor and the Provost of the respective hall.
 - v) No clubs or students organization shall be allowed to be formed. No parties or entertainments shall be held within the premises of the University nor shall a student use a loud speaker in the University premises during or after University hours without the previous permission of the Proctor.

A breach of this rule will be treated as breach of discipline.

- vi) The Proctor may take suitable action against any student who wilfully damages, disfigures or destroys University properties, or gardens, or does not observe the rules to facilitate movement within the university and for keeping the University neat and clean.
- vii) Any in disciplinary activities occurred either in the premises of academic building or administrative building or any other places of the campus must be reported to the administration and/or to the proctor.
- viii) In an emergency, the Proctor or any of the Assistant Proctors can seek help of any employee of the University in the discharge of his duties in the University or outside, at all hours and it shall be the duty of the employee or employees concerned to give him every reasonable assistance.
- 6. No student of the University individually or collectively shall declare a "Strike" of the University students nor shall a student prevent another student of the University from attending the University classes, laboratories and library. A student found guilty of violation of the provision of this section will be liable to punishment up to expulsion from this University
- 7. No meetings of the students of the University other than the meetings organized by the University or by any Department of the University or by the University, shall be held in any part of the University without the previous permission of the proctor. No demonstration shall be organized within any part of the University.

A student found guilty of violation of the provisions of this section will be liable to punishment up to expulsion from the University.

8. The Proctor / Assistant Proctors shall exercise other rules depicted in the disciplinary rules of NSTU approved by 6th meeting of the Regent Board.
